Page 1 of 3

1. The HOUSE RULES shall govern ALL functions and activities held on Aerie property and shall apply, equally, to ALL members and their signed-in guests.
2. Gentlemanly and lady-like conduct is required of all members and their guests. Profanity, swearing, or vulgar language is not allowed. No fighting will be tolerated in or on Aerie property. Any person(s) who instigates, incites, intimidates, or harasses another person(s) to the point that they violate this House Rule will be considered to be just as guilty, if proven by the facts, as the person(s) who actually violates this House Rule, and should receive the same censure or punishment as the violating person(s).
3. Parents, grandparents, guardians will directly supervise children at all times while in or on Aerie property. No one under twenty-one (21) years of age shall be sold, served, or given alcoholic beverages. Children under eighteen (18) years of age are not allowed at the bar for any purpose.  
Children under eighteen (18) years of age may not be in the Aerie after 8:00 PM on Meeting nights. Children under twelve (12) years of age may not be in the Aerie after 9:00 PM. Special events and family functions are the exceptions.
4. No person in the state of intoxication will be served alcoholic beverages in or on Aerie property. The bartender is in charge at all times. If a member is asked to leave, that person must leave the Aerie property immediately.  
**THE BARTENDER'S DECISION IS FINAL!**
5. Guest(s)...a non-member of the Fraternal Order of Eagles...may be signed in a maximum of three (3) times by a member of the Fraternal Order of Eagles. (Aerie/Auxiliary) The guest(s) must then make application for membership in this Aerie to gain additional access. All guests must be signed into the Aerie Guest Book by their sponsor. The guest(s) must leave the Aerie premises when the sponsor leaves, unless their responsibility is assumed by another member. That member must, in turn, sign the Guest Book as the replacement sponsor. Members are responsible for their guest(s) at all times. Occasional out-of-town houseguests of members are excluded from this requirement.  
  
Guest/non-members **MAY NOT** purchase alcoholic drinks!  
  
A non-member cannot attend meetings (Constitution) !  
A non-member cannot purchase alcoholic beverages (State liquor law) !  
A non-member cannot sign the daily/weekly 'books' (State law)!  
A non-member will not be provided a key card (Aerie policy)!  
A non-member may not purchase Instant Bingo nor play any entertainment gaming machines. (State Law)
6. A member allowing admission to the Aerie of any suspended/expelled member shall himself/herself be suspended for a period to be determined by the Board of Trustees.
7. The names of suspended/expelled members of the Order shall be posted in the Social Room of the Aerie.
8. Alcoholic beverages shall neither be brought into nor taken out of the Aerie property.
9. The bar(s) shall close fifteen (15) minutes prior to scheduled Aerie and District Meetings and shall remain closed throughout the meeting" Aerie and Auxiliary members shall attend such meetings or depart the Aerie premises during meetings"

10. All Aerie meetings shall begin promptly at the schedule times"
11. No illegal drugs are allowed at any time in or on Aerie property. No firearms will be permitted in or on Aerie property at any time other than for a formal Memorial observance, **or in the case of a sworn law officer.**
12. The Board of Trustees, under the direction of the Aerie, is the sole authority in Aerie operations, functions, activities, and use of Aerie property. Members will air their complaints or concerns with the Board of Trustees, not the bartender or any other Aerie employee or member.
13. All complaints, concerns, or accusations must be in writing, be substantiated by witnesses, and be made when the complainant is in a stable and sober condition.  
  
Any negative discussion concerning Aerie business of any kind at any place other than at an Aerie meeting will be deemed conduct unbecoming an Eagle and may result in suspension by the Board of Trustees or other action under Section 63 of the Constitution and Statutes of the Fraternal Order of Eagles.
14. Proper and suitable attire is required after 7:00 PM. Clothing bearing lewd or obscene markings, short shorts (Defined as anything shorter than halfway down the thigh), tank tops, halter tops or tube tops are all examples of attire that is neither proper nor suitable for wear in the Aerie.
15. Members and guests using Aerie facilities (pool tables, all gaming machines, card tables etc.) will clean up their area upon completion of their activity. Neither Food nor drinks should be placed on the pool table, nor should members or guests sit on the tables at any time.
16. Any person desiring entrance to the Aerie, or services of the Aerie, must present their Official Receipt (member card) upon request of the bartender and/or Officer or any other person properly designated by the Board of Trustees.
17. The bartender may accept a member's personal check for up to the amount of \$ 50.00 without the approval of a member of the Board of Trustees. Any member submitting any check to the Aerie that is returned from the bank "**Not Sufficient Funds**" will be assessed our banks service charge for each returned check. Check cashing privileges will be suspended until such returned check is made good and the service charge is paid. Refusal to redeem a bad check and/or pay the service charge could result in suspension of privileges or a formal complaint to the Trial Committee. Out of state checks will be accepted only with the approval of an Aerie Trustee or other bonded officer of the Aerie.
18. Anyone wishing to solicit money or offer goods or services for charge on Aerie property must first obtain permission from the Board of Trustees.
19. To insure compliance with state and federal laws dealing with a liquor license this Aerie shall not be opened unless the scheduled bartender is on duty.
20. Smoking shall not be allowed in any area of the Aerie building or within twenty-five (25) feet of any Aerie entrance or exit. This includes any smoking paraphernalia such as ash trays, chairs, tables etc.

23. As authorized by Section 70.13, Constitution and Statutes or laws amendatory thereto no person may be admitted as a guest to the Social Room if they have been rejected for membership by the Aerie or Auxiliary. *grw*
